### School Dance Information and Permission Slip



**6<sup>th</sup> Graders: Thursday, September 14<sup>th</sup> from 3:30pm-6pm in the MPR**

**7<sup>th</sup> & 8<sup>th</sup> Graders: Thursday, September 14<sup>th</sup> from 6:30pm-9pm in the MPR**

If you purchased an **All-Dance Pass**, your student will go directly to the Dance, they must bring their I.D. with them.

If you **did not purchase** an All-Dance Pass, please **read the school dance behavior expectations below, complete and sign the Permission Slip form**. For \$5.00 and this permission slip, students will be allowed to attend the dance. Please bring this permission slip and the \$5 to Fallon's ASB/Payment Window **before school, during lunch or after school Monday, September 11<sup>th</sup> through LUNCH Thursday, September 14<sup>th</sup>**.

#### School Dance Behavior Expectations:

1. NO ID = NO ADMITTANCE TO THE DANCE. You must show your current student ID with a wristband to gain admittance to the dance.
2. If student will be arriving to the dance later than 7pm, notify Mary Armanuse – her contact information is below.
3. If your student was absent/sick day of dance s/he cannot attend the dance that evening.
4. Dress Guidelines: No short shorts, short skirts, spaghetti straps or saggy pants are allowed. Students who are not appropriately dressed will not be admitted.
5. Inappropriate dancing is not allowed.
6. Cell phones and cameras may not be used by students or parents inside the MPR during the dance (this includes texting). Students and parents may take photos in the MPR foyer before the dance with the permission of those being photographed.
7. Bring money! Pictures, water and various treats will be available for purchase.
8. **NO BACKPACKS are allowed at the dance.** There will be a bag check area for any purses or small items. Students are encouraged to wear clothing with pockets to secure money and phones. They will not be allowed to go in and out of the bag check during the dance.
9. If your child has been suspended in the past 30 days, s/he is not eligible to go to the dance.
10. Students will not be released early unless they are **signed out by a parent in the MPR foyer or by an adult with a parent's written permission of release. There will be no early releases between 8:30pm-9pm.**
11. **Students must be picked up no later than 15 minutes after the dance has ended. Failure to do so could result in the inability to attend the next dance.**
