ALL-DANCE PASS and Permission Slip



The Fallon Associated Student Body (ASB) will host four dances in 2019-2020. For \$20, the All-Dance Pass covers the admission cost and serves as a permission slip for all four ASB dances, including the combined Cottonwood/Fallon/Wells dance. **It does NOT include the 8th Grade Promotion Dance.**

1. Friday, September 13, 2019. Two dances on one day: one for 6th grade and one for 7th & 8th grade.
2. Friday, December 6, 2019. All grades.
3. Friday, March 20, 2020. All grades. Combined Cottonwood Creek/Fallon/Wells middle schools.
4. Friday, May 15, 2020. All grades

School Dance Behavior Expectations:

1. Student must show current FMS ID to enter the dance. **NO ID = NO ADMITTANCE.**
2. Student must attend school on the day of the dance. If student is sick/absent during the school day, they may not attend the dance.
3. Dress Guidelines: No short shorts, short skirts, spaghetti straps or saggy pants are allowed. Students who are not appropriately dressed will not be admitted.
4. Inappropriate dancing is not allowed.
5. **NO BACKPACKS.** There is a bag-check for purses or small items. Students are encouraged to wear clothing with pockets to secure money and phones. Students may not go in and out of the bag-check during the dance.
6. Cell phones may not be used by students or parents inside the MPR during the dance (this includes texting). Students/parents may take photos in the MPR foyer before or after the dance, with the permission of those being photographed.
7. Students who've been suspended in the 30 days prior to the dance are not eligible to attend.
8. If a student will arrive at the dance later than 7pm, notify Kristin Werder –contact information is below.
9. Bring money! Pictures, water and treats will be available for purchase.
10. Students may not leave early unless they are **signed out by a parent or by an adult with a parent's written permission of release. There are NO early releases during the last half hour of a dance.**
11. Supervision of students ends 15 minutes after a dance ends. Students must be picked up by this time. Failure to pick up a student promptly may result in the student not being allowed to attend future dances.
